

FRESH START ACKNOWLEDGEMENT

The Fresh Start initiative restores Title IV financial aid eligibility for borrowers who defaulted on their federal student loans prior to the pandemic payment pause. Once new aid is disbursed to borrowers who qualify under the Fresh Start initiative, the Department of Education will automatically initiate a transfer of the borrowers' defaulted loans to a non-default loan servicer.
